**\*By signing this agreement I, and the organization I represent, agree to abide by the *Rules and Regulations of the Tucson Rifle Club (TRC)*:**

- We understand that the prime priority of Tucson Rifle Club is *safety* and agree to conduct our events with the highest standards for the safety of our participants and for all others.

***Rules and regulations of the Tucson Rifle Club (TRC) continued:***

- We will provide trained safety officers to supervise our events.
- We will be responsible for our participants and spectators, for range safety, range conditions and cleanliness.
- We understand that this agreement does not eliminate our liability should an incident occur.
- We understand that our responsibility covers our events and our agreement does *not* allow our participants to use the range facilities *before or after our event*.
- We understand that we are responsible for match set up and cleanup.
- We understand that we must provide temporary toilet facilities for our events that last more than six hours in duration with 50 or more people—this includes both participants and spectators.
- We understand that there is an advanced scheduling procedure and that all reservations and cancellations must be made in writing. We also understand that reservations cannot be made if fees are unpaid.
- We agree to pay a \$75.00 cancellation fee if cancellations are not made in writing at least 48 hours prior to the scheduled event.
- We agree to pay **Tucson Rifle Club** all applicable fees within five working days after each event.
- We understand that we must carry our own liability insurance (see attachment) to cover our activities at **Tucson Rifle Club**, and that the *State of Arizona* and the *Arizona Game and Fish Department* and (see attachment) will be named in the said policy as additional insured. A current copy of the certificate will be provided to **Tucson Rifle Club** and kept filed with this agreement. A lapse of insurance coverage nullifies this agreement.
- We acknowledge that we have read and understand the [Facility Procedures](#) and all posted safety signs and agree to abide by these.
- We understand that non-compliance with this agreement, or rules, procedures and instructions from TRC Rangemaster, or safety violations, or late payment of fees will result in loss of privileges to use this facility.
